B. Rights of the authors.

C. Permitted uses by authors.

1. Final published version of the manuscript. RAPDOnline allows authors the following rights with respect to the published version of the manuscript:

a. Copies for colleagues. Authors have the personal right to send individual copies in any format to colleagues upon request, free of charge.

b. Reuse in other publications.
